Terms and Conditions of the promotion "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 € "

§1. General information

1. The organizer of the promotion "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €" is R-GOL Marcin Radziwon Sp. K. based in Górka 3D (14-100 Ostróda), registered in the register of entrepreneurs belonging to the Olsztyn District Court, the 7th Economic Section of the National Court Register under the number KRS 0000630273, REGON: 365129350, NIP 741213294, hereinafter referred to as the Organizer .
2. The promotion is valid from 20.03.2023 until stocks last or until the date set by the Organizer. It covers goods and transactions concluded in stationary stores owned by R-GOL, as well as in the online store www.R-GOL.com.
3. Information about the Promotion, together with its Regulations, is available from sellers in stationary stores and on the website.

§2. Definitions

1. Organizer - R-GOL Marcin Radziwon Sp. K., whose data are specified in § 1 point 1 of this Regulation.
2. Promotion "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €" - promotion organized by the Organizer under the conditions of the content of these Regulations.
3. Regulations - these rules that define the terms and conditions of participation in the Promotion.
4. Participant - Client of the online store www.R-GOL.com or of one of the stationary stores being a consumer, who is a natural person, legal person or an organizational unit that is not a legal person, to which a separate law grants legal capacity.
5. Stationary stores - stores owned by R-GOL Sp. Z o.o. Sp. K. located at one of the following addresses:

6. Duration of the promotion – from 20.03.2023, 9:00 a.m. until stocks run out or until another date specified by the Organizer, during which the right to use the discount from the Promotion "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €" is granted by the terms and conditions indicated in the Regulations.

§3. Terms and Conditions of the "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €" Promotion

1. Any Participant may participate in the Promotion.
2. The promotion does not apply to items covered by other promotional action (including discount codes and loyalty program points), especially sales and special actions.
3. The promotion includes:

 - Adidas Al Rihla 2022 Club ball size 5 - available <https://www.r-gol.com/en/ball-adidas-al-rihla-2022-club-size-5,p-151920>
4. To benefit from the Promotion, the Participant must:
 - in the case of an online purchase:
 - add to the basket at least one pair of boots from the products available on the website <https://www.r-gol.com/en/adidas-1-plus1>
 - then add at least one Adidas Al Rihla 2022 Club size 5 ball to your basket - available <https://www.r-gol.com/en/ball-adidas-al-rihla-2022-club-size-5,p-151920>;
 - the system will automatically calculate the discount, after which the Adidas Al Rihla 2022 Club ball size 5, available <https://www.r-gol.com/en/ball-adidas-al-rihla-2022-club-size-5,p-151920> it will be 1 €.
 - in the case of a purchase from a stationary store:
 - select at least one pair of adidas boots from the collections: Own Your Football, Pearlized, Nightstrike and Messi Pack, all with a price of over 76,60 €;
 - decide to purchase the Adidas Al Rihla 2022 Club size 5 ball as long as it is available in the store's stock;
 - After selecting the right boots, the price of the ball will be automatically reduced to 1 €.
5. In the case of purchasing several adidas boots, e.g. two four, six, eight pairs, etc., the Promotion Participant will be entitled to buy one, two, three, four, etc. adidas Al Rihla 2022 Club balls size 5 for €1.
6. A Promotion Participant may repeatedly participate in the Promotion during the Promotion period, provided that each time the Terms and Conditions specified in the Regulations are complied with.
7. Products may be returned in accordance with the applicable return policy, but only all products included in the Combined Promotion. It is not possible to individually return the products purchased under the Promotion "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €"

§4. Complaints

1. All complaints regarding the way in which the Promotion is carried out shall be submitted by the Participants in writing to the Organizer's address or to the e-mail address @R-GOL.com with the mention "Complaint" within 14 days from the appearance of the theme for complaint, but no later than 7 days after the end of the Promotion. The date of receipt of the complaint by the Organizer is decisive. Complaints sent after this time will not be considered.
2. The complaint must contain the name, surname and exact address of the Participant, e-mail address: eSklep@R-GOL.com, a detailed description and justification of the complaint, as well as the content of the request.
3. The Organizer will consider the complaint within 14 days from the date of its receipt and will notify the Participant of the way to examine it by mail to the address provided in the letter or by e-mail (depending on how the complaint was received by Organizing). Providing a response to a complaint within the deadline is considered sending a response letter/email within the deadline. The Organizer may request additional statements from the Participant to justify the basis of the complaint.
4. After exhausting the complaint procedure, any disputes will be settled by the joint court with jurisdiction over the Organizer's headquarters.

§5. Final decisions

1. These Regulations are the only document that defines the detailed rules of the Promotion entitled "Buy adidas boots from the selected ones of at least 76,60 € and get a ball for 1 €"
2. By participating in the Promotion, the Participant confirms that he agrees to comply with the provisions of the Regulation.
3. The operator of the personal data of the Promotion Participants is the Organizer.
4. The organizer declares that the personal data processed will be secured and used only within and, respectively, for the purpose of ensuring access to the Promotion or concluding agreements and managing complaints, in accordance with the Law on the protection of personal data, i.e. of June 13, 2016, hereinafter referred to as "the Act".
5. The organizer declares that the processing of personal data will be carried out in a manner that ensures compliance with the requirements of the Law.
6. Participants have the right to access and correct their personal data and request its deletion.
7. The organizer reserves the right to modify these Regulations at any time, without providing any reason. However, changes to the Regulations must not violate the rights acquired by the Participants.
8. In matters that are not regulated by this Regulation, the provisions of the generally applicable law shall apply.
9. The regulations enter into force on 20.03.2023 and apply to agreements concluded during the Promotional Offer period.
10. Participation in the Promotion is equivalent to acceptance of these Regulations.

The Organizer reserves the right to withdraw this Promotion before the date indicated in § 1(2).

The exercise of the right mentioned in the previous sentence by the Organizer will not affect the validity of the agreements concluded under the terms and conditions of these Regulations.
